- 4. <u>In Accordance With ORC 121.22G4</u> Preparing for, conducting, or reviewing negotiations or bargaining sessions with public employees concerning their compensation.
- 5. <u>In Accordance With ORC 121.22G5</u> Matters required to be kept confidential by federal law or regulations or state statutes.
- 6. <u>In Accordance With ORC 121.22G6</u> Details relative to the security arrangements and emergency response protocols for a public body or a public office
