RESOLUTION 6-15 BOND FOR BOARD PRESIDENT, SUPERINTENDENT AND TREASURER

The handling of funds and signing fiscal certificates are requirements in varying degrees of the Board President, Superintendent, Treasurer and Assistant Superintendent. The signing of fiscal certificates states that sufficient funds are available to operate a school district. Statute recommends that the President, Superintendent, Treasurer and Assistant Superintendent have a bond covering them for any liability and this bond be established for at least \$20,000.00. Currently the Board President, Superintendent and Assistant Superintendent have \$20,000 bond and the Treasurer a \$100,000 bond that coincides with each position's term of office.

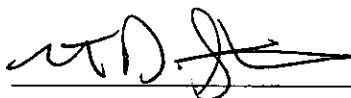
RESOLUTION 9-15 ADJOURNMENT
