

SHEA STADIUM TRACK USAGE POLICY

Residents of the City of Norwood may be permitted to use the track surface at Shea Stadium by following the prescribed herein. This policy is limited to individuals requesting usage of the Shea Stadium track surface. Groups, teams or individuals intending to profit off of this usage may be subject appropriate charges to use any and all facilities at Shea Stadium.

1. The cost to use the track surface is as follows:
 - Senior Citizen (55 years of age and older)- No Charge
 - Norwood Resident- \$12.00 per year
2. Applicants must be at least 21 years of age. Applicants may apply for 1 pass per household.
3. Applicants must provide two forms of identification indicating proof they are a resident of the City of Norwood. Acceptable forms of identification are as follows: current utility bill, mortgage/lease statement and an Ohio Drivers License/State I.D.
4. Applicants must submit an "Application for Shea Stadium Track Use". The application is available on the school district web site as well the Norwood City School District Board of Education Office. Completed applications must be turned in to the NCSD Board of Education Office.
5. Upon submission and payment of the applicable fee applicants will be issued a stadium access card and a copy of a permit for usage of the Shea Stadium track. All permit holders or members of the household are required to have their permit with them at all times while using the facility.
6. The issued stadium access card will be active for a period of 12 months. At the conclusion of this time period the card will be de-activated and the process detailed in this policy must be repeated for the card to be re-activated. A new permit will be issued at the time of renewal as well. Once de-activated, processing time for re-activation is one (1) week. All permits will state the time period in which access to the facility has been granted. All school related practices, games and events take precedence over public utilization of the track. No public access to the track will be permitted while the events are taking place.
7. The permit allows for usage of the Shea Stadium **TRACK ONLY**. Permit holders are prohibited from using any other facility or equipment on site at Shea Stadium including but not limited to the press box, bleachers, locker rooms, athletic equipment and athletic field playing surface. No equipment or devices with wheels (bikes, skates, etc.) are permitted for use on the track or inside of Shea Stadium. Medically necessary equipment may be allowed on a case by case basis.
